Jugglers must continuously juggle at least 3 objects and any drops must be retrieved and restart where dropped.

Jugglers may double-up on prize money by finishing as Overall Winner!!

\$250 and trophy for 1st Overall Male & Female, \$100 for 2nd Overall M & F and \$50 for 3rd Overall M & F

You do not have to a juggler to enter this race, it is open to any and all runners.

Medals to top three age group finishers (19 and under, 20-29, 30-39, 40-49, 50-59, 60 and over).

Overall winners receive a plaque and prize money but are not eligible for age group awards.
